How to Save a Heritage House

It started as the home of Colonel Robert Nelles and his first wife Elizabeth Moore in 1798. Here they had eight children at a time when the Forty (Grimsby) was just an idea. They began by clearing the land, starting a farm, and surviving the wilderness. While his neighbours were building log cabins or clapboard houses, he decided to build in stone. He was influenced to build the Georgian style manor house by the home of Sir William Johnson and Molly Brant – Johnson Hall. Sir Johnson was Robert and his father Hendrick's commanding officer with the British Indian department in the Mohawk Valley in New York state. That building was made of limestone. He found that there wasn't any limestone to be found at the Forty, so he used local Grimsby Foundation stone and parged the building and had large blocks drawn onto it. The building is very sound and well made.

It is believed that the Manor survived the War of 1812 due to the Engagement at the Forty. The battle took place on Robert and his brother's land along Forty Mile Creek with the Americans leaving all their possessions. They fled and

never returned. During the war large houses and sometimes villages were burned. Nelles Manor survived.

Elizabeth and their son Robert II died during the war. Robert remarried widow Maria Jane Waddell Bingle. She had two children from her first marriage and Robert and Maria Jane added six more children to the family. In peace the family and the Manor prospered.

The next four generations of the Nelles/Rutherford family cared and protected the building and lands the best they could. Over these generations much of the land was divided amongst family members and/or sold. In order to keep the Manor, it was divided into eight apartments.

In 1971 the last family member living at the Manor – Margorie Harris Rutherford – sold the Manor to the Coutts family. Over the next 40 plus years they took on the responsibility of caring and protecting the Manor. They slowly restored the Manor to one home with the attic and carriage house still available for tenants. They filled the home with period furnishings, artifacts, and art. They created Nelles Manor Museum when they donated the building and grounds to a not-for-profit organization to benefit the people of Grimsby and Ontario in 2016. Nelles Manor survived once more.

Now it is the time for the community to help with the stewardship of Nelles Manor and grounds. That is how we save a heritage house. To another 225 years and more!
